

Dear Vice-President Timmermans, dear colleagues and all people that are connected today,

Today is a special day because we are launching an intergroup that is the first of its kind, bundling interrelated and horizontal dimensions that are central to our society and our economy: **industry** and **investments**.

We have the ambition to become a Forum for open and targeted discussions among those key players that are able to enact the green and digital transition that we need to undertake.

I would like to stress three points:

1) Firstly, the horizontal nature of the intergroup. The intergroup does not have a precise sectoral connotation, it has rather a horizontal nature, and it embraces all legislative committees and interests all productive sectors.

Mr. Vice President, our intergroup could be, for example, the perfect partner to discuss **the work programme 2021**. The document proposes many



legislative actions touching industry and investments. Looking at those initiatives, the first great challenge is to keep coherence of actions and final objectives.

2) The role of research, innovation and technology. Clean affordable technology will be crucial to achieve of our target of being sustainable and climate neutral, while also keeping jobs, competitiveness and well-being.

Some sectors are ready to set new standards for the global competition and can transform easily and steadily, thanks to available technology and innovation. Some others still require large investments mainly in pilot and demonstration of new clean technologies. I am thinking in particular in the **carbon-intensive industries**. We must increase upfront investments in research and innovation to switch those industries to clean technology.

Mr. Timmermans, how can we ensure coherence between MFF, Recovery Plan and Green Deal?



3) Lastly, the need to reduce red tape. We know that VP Timmermans has been a crusader for better regulation and simplification. However, this is a continuous battle. We need to improve our creativity and entrepreneurship attitude through an overall simplification of rules and procedures, mainly for the enterprises. In the Industrial Strategy put forward by the European Commission, it is essential to have a 15th horizontal ecosystem dedicated to create an environment favourable to innovation and investment.

Mr. Vice President, I hope we can enjoy the fruitful collaboration that we are inaugurating today and that you and your colleagues in College will be again our guests engaging with MEPs and stakeholders in discussions that make our Europe a better place to live.
