MEPs' support for a strong and dedicated follow-up of the Intelligent Energy Europe Programme (IEE) within the Multi-annual Financial Framework

Dear Mr. Barroso,

Dear President of the European Commission,

The European Union has developed an **ambitious set of legislation** and strategic decisions in order to make the **EU competitive**, **sustainable and inclusive**: Strategy EU2020, the Renewable Energy Directive, the recast EPBD, the Energy Efficiency Plan, the upcoming Energy Efficiency Directive – all are milestones in the development of the EU. But it takes more to win the future: all policies need strong support to make them happen – they need **involvement and activation of stakeholders** on the ground... and they need a tool which addresses non-technical issues and barriers on the markets.

With the **Intelligent Energy Europe** programme, the European Commission had developed such a unique tool and proven to understand the necessities of renewables and efficiency markets and the needs of customers all over Europe. The Commission should continue this very constructive effort which brings EU goals to where real changes take place: right on the ground – on the markets, in the cities, in the lives and homes of our citizens.

With great pleasure, we followed the work, the success and the added value of the IEE programme and its Executive Agency (EACI) in the field of renewable energy and energy efficiency over the last years. Hundreds of impressive projects, thousands of organisations and tens of thousands of key actors have been inspired, empowered, guided and co-funded by this very successful programme. And they reached millions of EU citizens with their activities.

Activities like the outstanding **Covenant of Mayors**, which brings the Mayors and Cities together in an impressive joint effort, are unprecedented and should be continued and intensified.

Without the co-funding of the IEE programme, most of these activities would not have been possible – a huge loss for the future of EU energy policies and the development of innovative markets and new jobs.

Therefore, we urge you and the European Commission to assure a dedicated and visible place for Intelligent Energy Europe and its highly effective Executive Agency EACI or an improved and upgraded IEE successor programme within the Multi-annual Financial Framework. DG Energy should keep its only instrument to be able to react quickly on new market developments and to use corrective measures to assure a satisfying implementation of EU sustainable energy legislation.

We, MEPs from all major political groups of the European Parliament would hereby like to express our **strong support** for an ambitious, enlarged and secured **follow-up** of the highly important **Intelligent Energy Europe Programme (IEE)**.

We therefore would be grateful if you would clarify for us where in the MFF you foresee this programme being funded and how the institutional setting will be designed in order to continue the success of IEE. We are ready to discuss with you any time on your ideas and look forward to your answer.
